Dear Mr. Mabson:


Please be advised that the undersigned has been retained by the above-referenced Messrs. Again, Mr. Mabson, please be advised, in no uncertain terms, that this matter is quite serious, and my clients are not making empty threats. You are requested to immediately cease and desist from any and all tortious and/or defamatory communications regarding Messrs. Omar and Alston to **any third parties**. In good faith, Messrs. Omar and Alston will allow you a period of **two weeks** from the date of this letter to have remove and/or delete any and all references to them from your website. If the defamatory information is not removed from the website by the end of business on **October 11, 2004**, we shall commence litigation by filing claims for libel and slander and tortious interference against you in Broward County Circuit Court.
